Course Description:

Distance: 5,000 meters and 10,000 meters Location: Marine Park Start Time: 9:00 AM Registration Fee: 2 dollars, from 8:00 AM until 8:50 sharp The first Governor's Cup Foot Race. Runners left Egan Drive for the sidewalk approaching Willoughby Drive and stayed beside the highway as far as Old Glacier Highway, then ran on the edge of the road facing traffic. At the old Salmon Creek power complex the 5,000 meter runners turned into a rope chute while the 10,000 meter runners carried on along the bike path and down Old Glacier Highway. Registration closed at 8:50 "whether there are runners waiting to sign-up or not". Eighteen officials worked the race. Runners lined up by their own racing speed, chalked on the road behind the start, so the field would spread quickly. Name tags were pinned to the left shoulder and removed by an official at the end of the finish chute - runners were asked not to leave the chute before that, so the times would be right. T-shirts were handed out on the day until they ran out, and anyone who missed one waited three or four weeks for the next order. Having read this waiver and knowing these facts and inconsideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release the Juneau Trail and Road Runners, the United States Forest Service, the state of Alaska, the City and Borough of Juneau, and the Road Runners Club of America, all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver. In addition, I acknowledge the contagious nature of communicable diseases and voluntarily assume the risk that I may be exposed to or infected by communicable diseases by participating in this event.
