Course Description:

Distance: 3.1 miles, climbing 2,000 feet above sea level. There is no set course between the start and the finish. Location: start in front of the Foggy Mountain Shop on Franklin Street, downtown Juneau; finish at the cross above the tree line on Mount Roberts Course: runners enter the trail at the top of Sixth Street on Starr Hill and may choose their own route from Franklin Street to that point, provided it avoids private property. Runners are asked to stay off the worn short cuts where the established trail switches back. Start Time: 9:00 AM. Registration in the shop from 8:30 AM, closing at 8:55 sharp. Registration Fee: 9 dollars, including a T-shirt for the first 50 to register Sponsored by the Foggy Mountain Shop. Runners under 18 must pre-register and have an adult sign for them. Arrange for someone to meet you at the top with warm clothing, food and liquids. A race in the Empire Cup Runners Series.

Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release the Juneau Trail and Road Runners, the United States Forest Service, the state of Alaska, the City and Borough of Juneau, and the Road Runners Club of America, all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver. In addition, I acknowledge the contagious nature of communicable diseases and voluntarily assume the risk that I may be exposed to or infected by communicable diseases by participating in this event. I acknowledge that such exposure or infection may result in personal injury, illness, permanent disability, and/or death.
