Distance: 5 kilometers, accurately measured Location: start at the Dimond Courthouse, downtown Juneau; finish in the parking lot at the base of Hospital Drive Course: past the Governor's Mansion, across Gold Creek on Calhoun, left on 12th Street and right on Glacier Avenue to the finish. Re-routed from previous years to remove a hilly section in the highlands, and flat and fast as a result. Start Time: 10:00 AM. Pre-registered runners arrive about 9:30 for bibs and shirts; race-day registration from 9:00. Registration Fee: 5 dollars in advance with a T-shirt for the first 200, or 6 dollars on the day; 1 dollar for youngsters 13 and under Contact: Mike McKrill, 789-9116 Sponsored by the Southeast Road Runners and the Juneau Racquet Club. If allowed by the Race Director, and if I am pushing a baby jogger or stroller, I also accept the responsibility for injury up to death of the child being transported in the jogger or stroller. Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release the Juneau Trail and Road Runners, the United States Forest Service, the state of Alaska, the City and Borough of Juneau, and the Road Runners Club of America, all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver. In addition, I acknowledge the contagious nature of communicable diseases and voluntarily assume the risk that I may be exposed to or infected by communicable diseases by participating in this event. I acknowledge that such exposure or infection may result in personal injury, illness, permanent disability, and/or death.
