Course Description:

Distance: 26.2 miles, 13.1 miles and 8 kilometers Location: Sandy Beach, Savikko Park, Douglas Start Time: 8:00 AM for the marathon, 9:00 AM for the half-marathon and 8K Race Director: Bob Deal Registration Fee: 5 dollars, or 6 for the half and 8K on the day Out and back on the Douglas Highway, the marathon turning at the top of a hill beyond the False Outer Point parking lot and the half-marathon between the Bonnie Brae subdivision and Fish Creek, with eight or nine aid stations. It remembers Frank Maier, a long-time Juneau runner with a penchant for distance events, who was killed in a crabbing accident in the winter of 1990-91. Certification by The Athletics Congress means the course can qualify runners for marathons with a time standard, Boston among them. It was measured twice by calibrated bicycle odometer and carries the standard 0.1 percent safety factor, so it is a little long. All three races counted toward the Empire Cup Runners Series, and a potluck followed at the Sandy Beach picnic shelter.

Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release the Juneau Trail and Road Runners, the United States Forest Service, the state of Alaska, the City and Borough of Juneau, and the Road Runners Club of America, all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver. In addition, I acknowledge the contagious nature of communicable diseases and voluntarily assume the risk that I may be exposed to or infected by communicable diseases by participating in this event.
