Course Description:

Dave Pusich 780-4525, e-mail: dpusich@gci.net. This is an adventure run following Perseverance Trail, up Mt. Juneau trail (roughly 3000 vertical feet) to the peak, along the rolling ridgeline, and back down via Granite Creek and Perseverance Trail. Due to the strenuous climb, distance, and hazards, participants must be adequately conditioned to participate, and to qualify must be able to complete a ? marathon in 2 hours or less. Participants must bring proper (i.e., synthetic - not cotton) clothing, a hat, gloves, lt. windbreaker, etc (contact race director with any questions prior to the run), fluids, and snacks. The run will be postponed if weather/snow conditions are judged poor. You must run with someone (we will help with groups if you don't come with someone). Register at the run start, between 7:00 a.m. and 7:30 a.m. Route and safety issues will be discussed before the run starts. A great place to recall our memories of Tom Casey.

If allowed by the Race Director, and if I am pushing a baby jogger or stroller, I also accept the responsibility for injury up to death of the child being transported in the jogger or stroller. Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release the Juneau Trail and Road Runners, the United States Forest Service, the state of Alaska, the City and Borough of Juneau, and the Road Runners Club of America, all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver. In addition, I acknowledge the contagious nature of communicable diseases and voluntarily assume the risk that I may be exposed to or infected by communicable diseases by participating in this event. I acknowledge that such exposure or infection may result in personal injury, illness, permanent disability, and/or death. I grant permission to all of the foregoing to use my photographs, motion pictures, recordings or any other record of this event for any legitimate purposes.
